Annual contest gives students experience of a lifetime

Co-op will send 2 juniors to Washington D.C., 2 to Jeff City



Every year electric cooperatives in Missouri sponsor contests to select delegates for the annual Youth Tour in Washington, D.C. A quick pose from some before they begin their journey!

For many high school juniors, writing another essay isn't exactly exciting—but New-Mac Electric is offering an opportunity that could turn a short paper into an unforgettable experience.

New-Mac Electric's tenth annual Youth Tour/CYCLE Contest gives high school juniors the chance to earn an all-expenses-paid educational trip to either Washington, D.C., or Jefferson City this summer.

To enter, students simply need to submit a short essay answering the question: *In what ways does an electric cooperative strengthen its community beyond providing electricity?*

The contest is open to high school juniors attending schools in Carthage, Diamond, East Newton, Joplin, McDonald County,

Neosho, Pierce City, Sarcoxie, Seneca, and Wheaton. Homeschooled and private school students in 11th grade who live within these districts are also eligible. Immediate family members of New-Mac Electric employees or board members are not eligible to participate.

The Youth Tour program is a week-long trip to Washington, D.C., sponsored by electric cooperatives nationwide. Each cooperative selects delegates who then travel with students from their state to the nation's capital. Missouri will send more than 100 students, joining nearly 2,000 peers from across the country. While in Washington, participants will visit iconic landmarks such as the Jefferson Memorial, Washington Monument, World War I Memorial, Smithsonian museums, the International Spy Museum, and more. Delegates also gain a deeper understanding of how the federal government works while building lasting friendships. More information about Youth Tour can be found at youthtour.coop.

CYCLE—short for Cooperative Youth Conference & Leadership Experience—is a four-day trip to Jefferson City that focuses on state government, cooperatives, and leadership development. More than 100 students will attend this immersive experience, which includes visits to the City Museum in St. Louis, the Missouri Supreme Court, and the State Capitol. Participants will also take part in a mock legislative session, debating a fictional bill from the House floor.
