## New-Mac Electric holds its 2025 Annual Meeting

### Cooperative returns over \$3 million in patronage capital to membership

New-Mac Electric Cooperative members gathered on Saturday, October 25, at Crowder College for the cooperative's 2025 Annual Meeting.

The event drew approximately 700 attendees, reflecting the strong community engagement and cooperative spirit that

define New-Mac Electric.

During the meeting, members celebrated a significant financial milestone — 28 consecutive years of returning capital credits. This year, the cooperative distributed over \$3 million — with 94% of current members receiving a check in 2025. This continued return of funds underscores New-Mac Electric's commitment to operating efficiently and giving back to its member-owners.

CEO/General Manager Stan Irsik opened his management report by expressing gratitude to all who attended and offered special recognition to veterans, police officers, firefighters, and first responders for their service and dedication to the community.

Reflecting on the cooperative's performance, Irsik summarized New-Mac's success in five simple words: "Your cooperative is doing great!" He emphasized that New-Mac's mission remains centered on its members, adding, "Our focus will always be on safety, reliability, and serving you."

In business portion of the meeting, Tim

Short and Jason Ruddick were re-elected for Board District 2 and 8 respectively. Dewey Allgood prevailed in District 7 over Maurice Mailes, who honorably served the cooperative for 40 years as a Director. The membership also passed a bylaw amendment making it mandatory for director candidates to have an established residency of at least one year in their district.

Attendees enjoyed exhibitors such as S&H Farm Supply, Bunker Hill Community Club and Eubanks Equipment. Members also were able to take part in a Health Fair provided by the Freeman Screen Team.

Bluegrass band, *No Apparent Reason*, provided lively entertainment, and members also had the opportunity to win electric bill credits and cash prizes, culminating in a \$500 grand prize drawing.

The meeting served as both a celebration of another successful year and a confirmation of New-Mac Electric's ongoing dedication to providing safe, reliable, and affordable power to the communities it serves.
